



- Imports from CFS to factory, exports from factory to the port
- 20′⁄40′ containers of dry cargo
- Containers weighing up to 22 MTons (additional charges apply for heavier cargo)



Terms and Conditions:

- The above rates are purely our transportation rates (they don't include manual labour charges incurred during loading / un-loading / stuffing / de-stuffing of the container).
- Please contact our sales representatives for quotations for customs clearance, CFS charges, etc.
- These rates are valid till 31st March 2020
- We request a 24-48 hours' notice for placement of trailer/container at your factory, considering traffic snarls
- Customs open order examination charges shall have to be paid as per actuals charged at the point of examination
- Container detention freetime : 24hours from placement at the factory; Detention of Truck : post free time INR 2,500/per trailer per day
- All rates quoted above are subject to GST as per the govt rules and regulations for trucking services
- The transporter arranges for General Third Party insurance and Cargo insurance is not covered under this scheme. In case of any claims, Maersk's vendor will produce a COF (Certificate of Fact)
- Storage and transit insurance is on the customer's account.
- The cost of Diesel will be considered as INR 70 per litre. Any further increase in rates shall be revised by 2% per 2 INR increment in Diesel prices
- Toll taxes are included in the quote based on current rates. Changes in toll charges will be passed on at actuals
- E-way bill (Part-A), wherever applicable, needs to be provided by the customer
- Lift On Lift Off charges will be chargeable as per actuals
